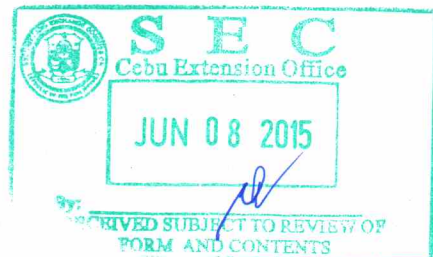

Item 9. Other Items.

Vivant Energy Corporation ("VEC") executed a Deed of Absolute Sale and a Share Purchase Agreement with Gigawatt Power, Inc. ("GPI") for the sale by GPI to VEC of 15% equity in Delta P, Inc. (the "Agreements"). Prior to the execution of the Agreements, VEC owned 35% equity in Delta P, while GPI owned 65%. The execution of the Agreements will result in a 50%-50% equity split between VEC and GPI in Delta P, Inc.

VEC is a wholly-owned subsidiary of Vivant Corporation. Delta P, Inc. is the owner and operator of a 16 MW diesel-fired power plant in Palawan with a power supply contract with Palawan Electric Cooperative, Inc. (PALECO).
